On November 15, 1939, defendant served and filed a complaint in the superior court alleging, among other things, that plaintiff had been employed by him to sew garments under his supervision and supervision, and during her employment she sustained serious and permanent injuries to her person, and that she "was employed under the Trade-School Section of the California Unemployment Relief Act of 1937." On the same day plaintiff served and filed her answer denying these allegations. On the same day defendant made and filed a verified claim with the Industrial Accident Commission as required by section 5405 of the Labor Code. On November 19, 1939, plaintiff filed her answer to defendant's complaint, and on the same day defendant made and filed a verified reply to plaintiff's answer. Plaintiff then moved to strike defendant's claim to the commission and also for an order vacating and setting aside the award on the ground that there was no substantial evidence to support the findings of the commission. On November 23, 1939, the trial court entered its order vacating the award and setting aside the order of the commission. On December 2, 1939, defendant filed his notice of appeal from the judgment. [1] The order of the trial court vacating the award and setting aside the order of the commission has been affirmed by this court. (Favre v. Barnes, (Cal.App.) 55 PaCal.2d 1038.) *471 [2] The appeal herein is from the order vacating the award and is not an appeal from the judgment. The record does not disclose a motion for a new trial in the lower court and the time for the defendant to move for a new trial under section 657 of the Code of Civil Procedure expired before the entry of the judgment.
