Has anyone had trouble with Openstack Juju bootstrap on CentOS 7? Could I run into any issues? I know there has been a few minor bugs in the last few weeks, but does this repo have a history of "integration" issues that are preventing Bootstrap/Deployment to work? Or is this now a solved problem in 7.x? I am able to get Juju bootstrap to work in a non-cloud-enabled system, but am having issues with Centos 7.x.
A: This is a fairly major bug that has been introduced in Juju 2.1. It affects CentOS, RHEL and Fedora (at least in a cloud-enabled environment). I know this is what you were trying to do, but it is not possible.

Until this bug is fixed, you can use Juju without the cloud, but it will not work with a bare metal environment. I understand this may not be an acceptable solution. You can downvote this issue, and see if the issue gets closed.

2019 Ontario municipal elections
Municipal elections were held in Ontario, Canada on October 22, 2019. The Ontario general election took place on June 7, 2018. In 2018, previous to the election, Premier Doug Ford and his government campaigned to balance the provincial budget, arguing that the fiscal situation was precarious. It was reported by The Globe and Mail and The Toronto Star that many of the principles of the Progressive Conservative Party were transferred to their provincial party in the municipal races. All mayors are elected for a fixed term of four years, with the exception of those in London, Windsor and Windsor Essex County, where mayors are elected for two years.
